EO 20-20

TO ALL TO WHOM THESE PRESENTS COME – GREETINGS:

EXECUTIVE ORDER TO ESTABLISH THE GOVERNOR'S ECONOMIC RECOVERY TASK FORCE

WHEREAS: An outbreak of coronavirus disease 2019 (COVID-19) has spread throughout the world resulting in a global pandemic; and

WHEREAS: On March 11, 2020, by Executive Order 20-03, an emergency was declared in the state as a result of COVID-19; and

WHEREAS: In response to COVID-19, significant targeted measures have been taken by Executive Order and Directives by the Secretary of Health to limit person-to-person contact, restrict gatherings, limit travel into the state, and suspend businesses that require significant person-to-person interaction; and

WHEREAS: These necessary targeted measures to mitigate the spread of COVID-19 have negatively impacted the economy and workforce of the State of Arkansas; and


WHEREAS: It is in the best interest of the state and its citizens to ensure that the state develops and follows a comprehensive plan for a controlled economic recovery effort from the effects of COVID-19;

NOW, THEREFORE, I, ASA HUTCHINSON, acting under the authority vested in me as Governor of the State of Arkansas, do hereby order the following:

- (1) There is hereby created the Governor's Economic Recovery Task Force, which shall serve as an investigative and advisory body of the Governor.
- (2) The task force shall be composed of members appointed by the Governor and shall serve at the pleasure of the Governor. The task force shall be composed of the following individuals, or his or her designee, and any additional members as deemed necessary by the Governor:
