




84. NARRATIVE OF THE FACTUAL BASIS FOR PROBABLE CAUSE: The undersigned certifies that he / she has just and reasonable grounds to beleive that the heretoafter named defendant did commit the violation as stated above and the factual basis for belief is as follows:

On November 9, 2021, approximately 1515hrs, your affiant Dep Derrick Swann, made contact with a white male subject Jason Gutterman. Jason was standing within 500ft of two school zones video taping the UPS building, a church and possibly students as they exited Mosley High School and New Horizon Learning Center. I approached Jason and asked if I could help him with anything. Jason refused to answer any questions, and continued to ask a question with a question.

I advised him at that time I would call for assistance so we both could further educate each other with this suspicious incident. As we waited on another unit, Jason continued to belittle me in my position with the Sheriffs Office, "stating if you had more rank you would know how to handling this situation". Approximately seven minutes later Sgt Larry Grainger arrived on scene and spoke with Jason in length about his disruptive behaviour as we attempted to inquire more information about why he was there. Because Jason refused to give his identity and explain why he was within 500ft of two school's video taping he was in violation of FS 810.0975. Jason also received a trespassing warning
